**ORDINANCE NO. 01 SERIES OF 2018
(INTRODUCED BY: HON. ANNABELLE M. MAPUTOL)**

AN ORDINANCE REQUIRING ALL HOUSEHOLD AND STAKEHOLDERS WITH IN THE BARANGAY IMBATUG, BAUNGON, BUKIDNON TO ATTEND QUARTERLY BARANGAY ASSEMBLY

BE IT ORDAINED, BY THIS COUNCIL IN SESSION HELD THAT:

SECTION 1. This ordinance are mandated all household and stakeholders to attend quarterly Barangay Assembly.

SECTION 2. In case the household owners or stakeholders cannot attend Quarterly Barangay Assembly he/she may send a representative on his/her in behalf, as long as that representative not less than 15 years old.

SECTION 3. Should any portion of this ordinance be declared unconstitutional or illegal by any court of competent in full force and effect.

SECTION 4: Violation of any provision of this ordinance shall be fined

1st offense ----- 2 hours community service or P 50.00
2nd offense----- 4 hours Community Service or P 100.00
3rd Offense & Subsequent Offenses-----1 day Community Service of P 150.00

SECTION 5. EXEMPTION – SENIOR CITIZENS AND THOSE WITH REASONABLE REASON WITH DOCUMENT ATTACH.


SECTION 6. EFFECTIVITY- This Ordinance shall take effect after review of the Sangguniang Bayan.

WHEREAS, this ordinance was submitted to Sangguniang Bayan on august 8, 2018 for review;

WHEREAS, the Sangguniang Bayan on August 20, 2018 called for a continuity hearing for some corrections introduced;

WHEREAS, because of election period this ordinance was archived in the Barangay office and with the change in Barangay Administration, its submission for final review to the Sangguniang Bayan had been made just recently.

THEREFORE, on motion of Hon. Annabelle M. Maputol and duly seconded severally.

BE IT RESOLVED as this council hereby resolved to enact.

ORDINANCE NO. 02 SERIES OF 2018
(INTRODUCED BY: HON. ANNABELLE M. MAPUTOL)

AN ORDINANCE PROHIBITING ANY INDIVIDUAL OF DISPOSING GARBAGE AND OTHER EYESORE MATERIALS IN ANY PUBLIC PLACES, MARKET, PLAZA, SCHOOL PREMISES, PROVINCIAL, MUNICIPAL AND BARANGAY ROADS, STREETS IN IMBATUG BAUNGON, BUKIDNON.

BE IT ORDAINED, BY THIS COUNCIL IN SESSION HELD THAT:

SECTION 1. This ordinance shall prohibit individuals of disposing garbage anywhere like: Candy Wrapper, Food Containers, diaper, cellophane, and other eyesore materials.

SECTION 2. Violators aging 18 years old below, parents are responsible for their children.

SECTION 3. Any individual may report violators to authorities, concerned Barangay officials tanods, Purok President.

SECTION 4. PENALTY CLAUSE. Violation of any provision of this ordinance shall be penalized by the following:

- 1st offense 30 minutes Community Service or a fine of P 50.00
- 2nd Offense 1 Hour Community Service or a fine of P 100.00
- 3rd Offense 4 hours Community Service or a fine of P 200.00
- Subsequent offenses 1 day Community Service or a fine of P 500.00

SECTION 5. COLLECTION, the Barangay Treasurer is authorized to collect the fines.

SECTION 6. SEPARABILITY CLAUSE- Should any portion of this Ordinance is declared unconstitutional or illegal by any court of competent jurisdiction the portion not so declared shall remain in full force and effect.

SECTION 7. EFFECTIVITY- This Ordinance shall take effect after the review of the Sangguniang Bayan.
