**BARANGAY ORDINANCE NO. 010
SERIES OF 2018**

(INTRODUCED BY: HON. MARJORIE C. JARAULA and HON. ROSA S. RAPIRAP)

**AN ORDINANCE REQUIRING ALL PERSONS WHO ARE CONDUCTING BUSINESS
IN BARANGAY IMBATUG TO SECURE FIRST A BARANGAY CLEARANCE FROM**

THE OFFICE OF THE PUNONG BARANGAY BEFORE CONDUCTING THEIR RESPECTIVE BUSINESS IN THIS BARANGAY.

BE IT ORDAINED, BY THIS COUNCIL IN SESSION HELD THAT,

SECTION 1. All persons conducting business of whatever kind in Barangay Imbatug, Baungon, Bukidnon shall secure first a Barangay Clearance from the Barangay prior to start with their businesses.

SECTION 2. For non-resident business operators or ambulant and transient vendors, it is a requirement to present their valid identification card (ID) and pay corresponding fees before a clearance be granted.

SECTION 3. Penalties for business operators/owners

1st offense ----- Reprimand
2nd and subsequent offenses ----- A fine of P 1, 000.00

SECTION 4. The Barangay Treasurer is authorized to collect payment of fees as will as the penalties imposed and issue corresponding receipts thereof.


SECTION 5. This Ordinance shall take effect after review of the Sangguniang Bayan of Baungon Bukidnon.

**BARANGAY ORDINANCE NO. 011
SERIES OF 2018**

(INTRODUCED BY: HON. MARJORIE C. JARAULA and HON. FRANCIS A. BEJA)

**AN ORDINANCE PROHIBITING MINORS TO ENGAGE IN GAMBLING
ACTIVITIES OR MAKING BET INSIDE PERYAHAN, LOTTO OR SMALL TOWN
LOTTERY AND OTHER VENUE FOR GAMBLING.**

BE IT ORDAINED, BY THIS COUNCIL IN SESSION HELD THAT,

SECTION 1.No minor is allowed to gamble or make a bet (pusta) inside peryahan, lotto, small town lottery and other gambling venues. They will be allowed to enter the venue but not to bet in any game of chance.

SECTION 2. Responsibility of the Parents or Guardian. Parents or Guardians shall be responsible in guiding their minor children not to bet in any games of chance.

SECTION 3. Responsibility of Peryahan Operator. Peryahan operator who accept or receive after bet to children shall be penalized for violation of this ordinance.

SECTION 4. Penalty for operators

1st offense ----- Reprimand
2nd offenses ----- A fine of P 500.00
3rd and Subsequent Offenses ----- A fine of 1, 000.00

Penalty for Parents

1st offense ----- Reprimand
2nd offense ----- Counseling with the DSWD
3rd and subsequent offenses----- A fine of 500.00

SECTION 5.The Barangay Treasurer is authorized to collect penalties which shall accrue to the general fund of the Barangay with a corresponding official receipt. .

SECTION 6. Barangay Officials and Bantay Bayan members are authorized to apprehend violators in coordination with Philippine National Police (PNP) any person who will violate the ordinance and shall receive 50% of the administrative fine collected.


SECTION 7.This Ordinance shall take effect after review of the Sangguniang Bayan of Baungon Bukidnon.

3rd and Subsequent Offenses ----- a fine of P 1, 000.00


SECTION 6. This ordinance shall take effect after review of the Sangguniang Bayan of Baungon Bukidnon.
