

**WHEREAS**, the Barangay Council find it appropriate to enact the following Ordinance thereof:

**BE IT RESOLVED** as this council hereby resolved to enact;

**ORDINANCE NO. 01 S. 2017  
(INTRODUCED BY : HON. ROSA S. RAPIRAP)**

**AN ORDINANCE REQUIRING ALL COUPLES TO GET MARRIED TO PLANT TWENTY (20)  
HILLS OF TREES.**

**BE IT ORDAINED BY THE SANGGUNIANG BARANGAY THAT:**

**SECTION 1. A REGULATED ACTS:**

All couples applying for a marriage license resides is required to plant Twenty (20) hills of trees and maintain it, prior to the issuance of certification.

**SECTION 2. DEFINITION OF TERMS:**

Tree planting shall be conducted in the following area;

- a. Barangay Tree Park at ICES Premises
- b. River Banks within the jurisdiction of Barangay Imbatug
- c. Residential area or farm lot area

**SECTION 3. ADMINISTRATIVE PROVISIONS:**

The Chairman of the Committee on Environment and the Barangay Council members and all Purok President are enjoined to conduct inspection and monitoring of the compliance to the herein provision.

**SECTION 4. PENALTY CLAUSE:**

No certification be issued without compliance to the Section 1 of this ordinance.


**SECTION 5. EFFECTIVELY CLAUSE:**
